



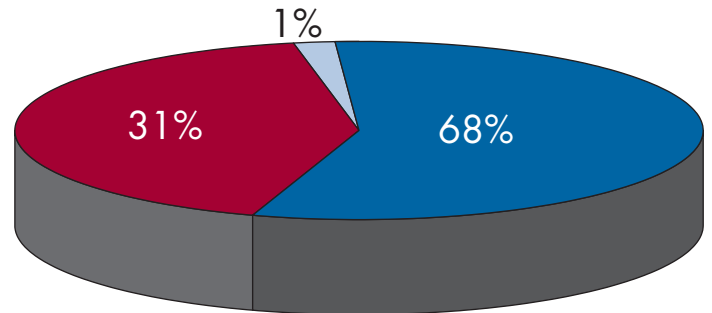
2012 annual report

By the Numbers...

The Homeless Families Foundation exceeded expectations during 2012 **serving 231 families**, including **509 children**, with a **success rate of 91%** of our families moved to permanent housing.

The Dowd Education Center **served 127 children** during the 2011-2012 school year and over the summer. The Center provided children with over **38,000 hours of tutoring, enrichment, homework assistance and recreational activities**. Our children in kindergarten through middle school made great strides in improving their math (95.5% improved from pre- to post-test) and improving and/or maintaining reading skills (95.5% improved from pre- to post-test).

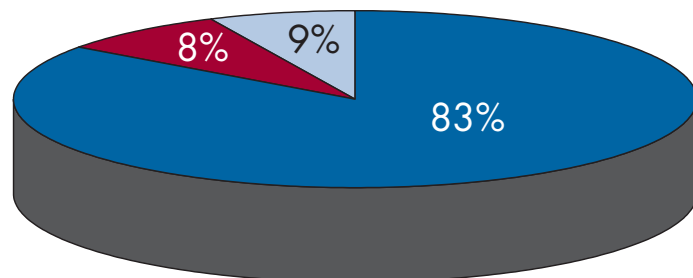
